

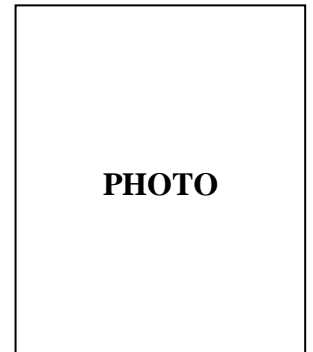

**DOCUMENTS CHECK-LIST AND REQUIREMENTS FOR A VISA  
(General Requirements for all categories)**

➤ **Passports**

- Passport should be valid for 6 months from the date of travel.
- Passport Scanned Copy (Front & Back) Latest by 20<sup>th</sup>, September, 2018

➤ **Photo Specification**

- 01 Scanned copy of recent Photographs.
- White Background only with contrasting Clothes .
- The Photograph should be a recent one not more than 6 month old
- Face should Cover 85% of area of Photograph
- Ears ,Chin, Nose, Eyes & Eyebrows must not be covered, the forehead should be uncovered to the extent that the shape of the face is apparent

- We Require 02 Passport Size Photo (35 x 45 mm ) With White Back Ground Per Pax
- Physical Passport Required 10 Days before to Departure and Scan copies at least 15 days Before to Departure.
